Thank you for considering Peace Academy for the education of your child(ren). The following registration packet has been thoughtfully designed to acquaint you with our school as you carefully consider the educational opportunities available for your family. At Peace Academy, we strive to offer opportunities for each student to grow into a committed, balanced and academically excellent Muslim-American citizen.

For students in grades Kindergarten through Twelfth, the annual cost to attend Peace Academy for the 2025-2026 academic year is **\$12,250** per child, including registration and other fees.

For students enrolled in the full-time Preschool program (K3 & K4), the cost to attend Peace Academy for the 2025-2026 academic year is **\$11,850** per child, including registration fees. For the convenience of parents/guardians, Peace Academy also offers a part-time Preschool program; the cost for which is **\$6,850** per child, including registration fees.

### Important Notes:

- For your child(ren) to be accepted into 2025-2026 school year, all past due balances must be paid prior to August 1, 2025.
- Registration and other fees (with the exception of tuition) as notated within the expense chart(s) are due by August 1, 2025.
- If you choose to participate in the 10-month payment plan, the expenses will be due by the 5<sup>th</sup> of each month starting August 2025 through the Blackbaud payment portal. Blackbaud will also charge an annual processing fee of \$55.
- A penalty of \$40 will be automatically assessed by Blackbaud if the payment is not received by the 9<sup>th</sup> of each month.
- All payments made in person are recommended to be paid by check or cash. Credit card transaction(s) are subject to additional charges.
- *Payments from the Oklahoma Tax Commission and Oklahoma Islamic School Foundation (OISF), allocated for your child(ren)'s private school expenses, will be directed to Peace Academy. These checks will need to be signed by parents or legal guardians in order to release the funds to Peace Academy to cover the 2025-2026 school year tuition for your child(ren).*

### Admission Requirements 2025-2026

Please carefully review the following guidelines to facilitate your application process. Parents/Guardians will receive admission status notifications upon the completion of the admission process.

Following items are required to complete enrollment:

- **Enrollment Form:** Ensure all required enrollment forms are duly completed and signed, including all supporting documents. Incomplete or inaccurate applications may result in delay and possible loss of admission.
- **Fees and Tuition:** Adhere to the Fee Schedule for the payment of all fees and tuition. ***The registration Fee is non-refundable. Once the child is in school, no refunds or cancellations of tuition and/or other fees will be made regardless of subsequent absences, withdrawal or dismissal of the student from the school.***
- **Financial Assistance:** Peace Academy offers limited financial assistance to qualified applicants. If you feel you are eligible for financial assistance, please contact Walid Shaker at [finance@patulsa.org](mailto:finance@patulsa.org) or by phone at 918-640-5051. Financial Assistance is funded primarily by Sadaqah, Zakaah and community members' donations. All financial assistance inquiries should be received by no later than June 30<sup>th</sup>, 2025.

**NOTE: Parents/Guardians are responsible for keeping student information current (address change, phone numbers, immunization records etc.)**

**For New Applicants,** following items are required in addition to the stated above.

- **Transfer Records:** For transferring students, a satisfactory report and a letter of recommendation from the previous school are mandatory. A signed release letter for the student's transfer record is also required. Please include copies of standardized exams from previous years and, if applicable, an Individual Education Plan (IEP) with the application.
- **Placement Test(s):** All new students are required to complete placement test(s) as part of the admission process.
- **Interview Process:** Both Parent(s)/Guardian(s) and student(s) are required to attend an interview as part of the admission process.
- **Age Eligibility:** Students must meet the minimum age requirement by September 1st of the academic year for which they are applying. For instance:
  - Pre-K3 students must be three years of age before starting pre-K3.
  - Pre-K4 students must be four years of age before starting pre-K4.
  - KG students must be five years of age by September 1<sup>st</sup> of the current year etc.
  - Eligibility for higher grades will be based on a combination of age, maturity, school records and the placement test / evaluation.
- **Waiting List / Availability of Seats:** Depending on the grade applied for, seats may or may not be available, and the applicant may be placed on a waiting list. In this event, you will be notified and given a waitlist rank based on the date your application was received.
- **Probation Period:** New students are on probation for the first year that they are enrolled at Peace Academy and may be dismissed from the school at any time for valid academic or disciplinary reasons.
- **Special Education / ESL:** Peace Academy does not currently offer special education / ESL or alternative programs and as such will not be able to enroll students recommended for these programs.

**NOTE: Admission for new students is contingent upon their successful completion of both the placement tests and interviews. The assessments and interviews are scheduled to occur during the summer.**

**Tuition, Registration, and Other Dues:** Tuition/Registration is based on a “full school year contract” and is due in full when a student is first enrolled. However, Peace Academy provides the convenience of 10 monthly payments. Parents are responsible for the entire tuition/registration per child. Also, when a child is enrolled at Peace Academy, it is considered a full school year commitment. Registration and tuition costs do NOT include cost of breakfast, lunch, special activities, supplies, fieldtrips, uniforms, etc.

I agree and commit to make prompt payments as stipulated in the “Fees Schedule” with applicable penalties for late payments. Monthly payments are due by the 5th day of each month; **a penalty fee of \$40 will be assessed after the 9th day of the month for non-payment.** There will be a minimum \$40 charge for any check returned (insufficient funds, account closed, etc.). I further understand that my child(ren) may not be allowed to attend class due to delinquent payments at the discretion of the school administration. I agree to provide two weeks’ notice if withdrawing my student(s); otherwise, I understand full tuition will be charged. **All new students are on probation for the first one year.**

I understand the school offers tuition discounts to make Islamic education affordable, creating a deficit covered by community donations. Starting January 1, 2024, this deficit can also be offset through refundable tax credits under Oklahoma’s private-school tax-credit program (House Bill 1934, passed May 2023).

**I understand that receiving the tuition plan is contingent on the following:**

1. Submitting an application for refundable tax credits to the Oklahoma Tax Commission by the deadline, in coordination with the school.
2. Providing the school with the application outcome.
3. If approved, applying the refunded tax credit for August 2025 to cover both parent/guardian payments and the school’s deficit for the 2025–2026 academic year.

**Cancellation:** Peace Academy may terminate this Enrollment Agreement with written notice. I understand that the school reserves the right to withdraw my child at any time for violations of its policies, practices, or standards.
